

PRODUCT USE GUIDE FOR ENVIROLOGICAL MULTIPURPOSE CITRA CLEANER R10

Product Description

An all-purpose cleaner. It is a safe alternative to many highly alkaline products designed for similar tasks. It is biodegradable, contains no phosphates and has minimal impact upon the environment.

Product Features

- A clear orange citrus fragranced all-purpose cleaner.

Recycling of Packaging

All of the primary packaging used in these products may be recycled or reused..

For 1000L intermediate bulk containers simply rinse well with cold water before reuse.

2x% and 20L Litres may be rinsed and reused or can be recycled at an appropriate recycling plant.

Direction for Use

This product contains water softeners which enable its use in any hardness of water without affecting the performance of the product.

Ensure that the product is used at the correct dilution rates, do not over or under dilute as this will affect the efficiency of the product and may give poor results. The product is designed to be used by dilution with cold water, however use of warm water (40C maximum) may be employed where soiling is difficult to remove.

- For the general cleaning of floors, walls, sinks, showers, WCs and most hard surfaces. Carefully dispense product from refill pack using a tap dispenser. Attach spray head and open nozzle. Spray onto a clean damp sponge or cloth. Apply to surface to be cleaned. Rinse out cloth or sponge with clean water. Rinse surface thoroughly with clean water. Allow to air dry.
- **Pressure Washers & Scrubber Dryers:** use 1:50 dilution rate (2% of the fresh water capacity of machine). After use rinse tank with clean water. Sanitize tank on a weekly basis with 1-2 chlorine tablets in the waste tank.
- **Dilution Rates:** 1:50 (2%), i.e. 100ml per 5 litres of warm to hot water (40C) up to 1:10 (10%), i.e. 500ml in 5 litres of warm to hot water, depending on degree of soiling.
